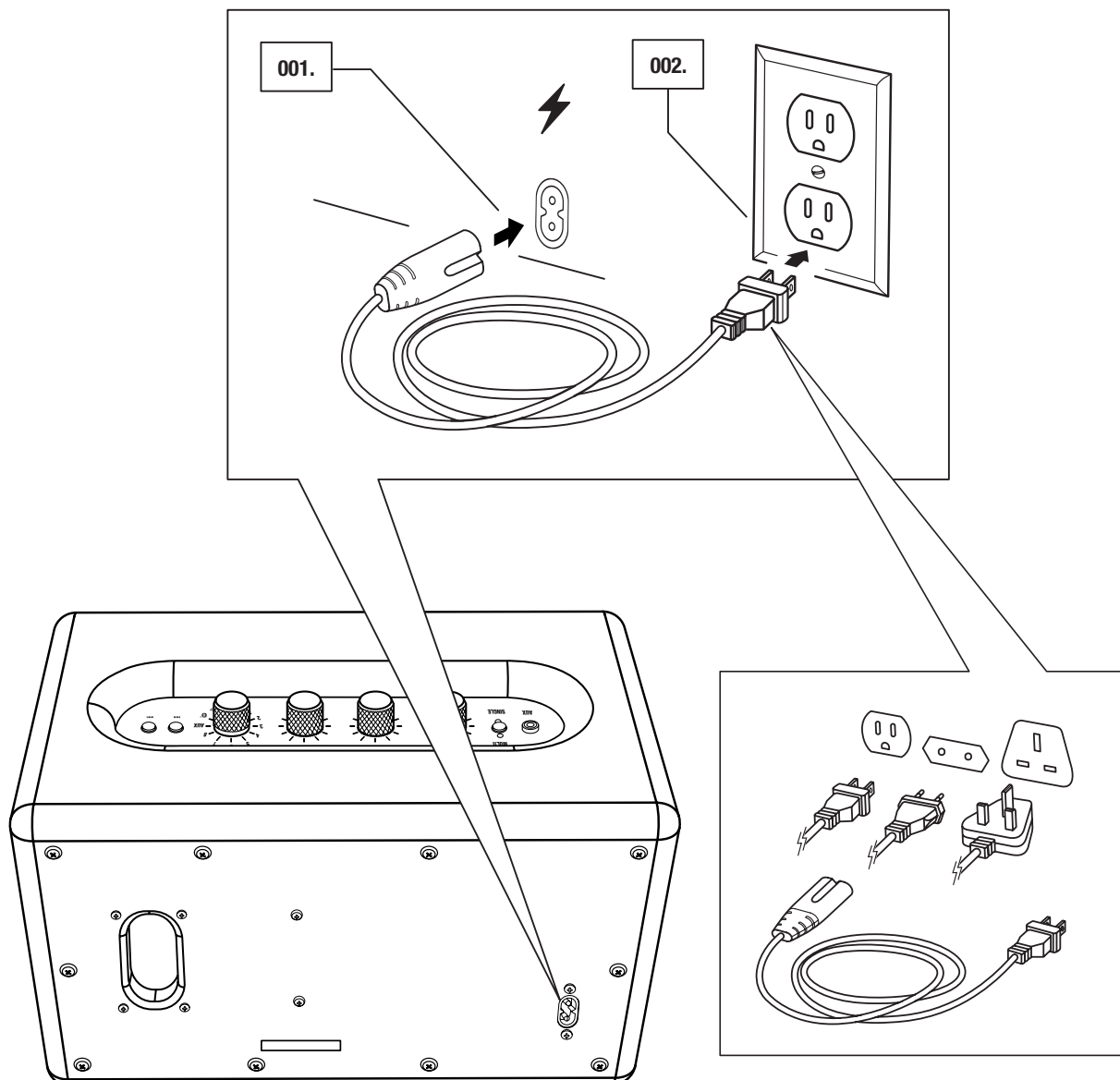
PLUGGING IN THE ACTON MULTI-ROOM

- 001. INSERT THE POWER CORD INTO THE POWER JACK ON THE BACK OF THE SPEAKER.**
- 002. CONNECT THE POWER PLUG TO THE WALL SOCKET.**
- 003. CONTINUE WITH THE SETUP IF THE SPEAKER HAS NOT YET BEEN CONFIGURED.**

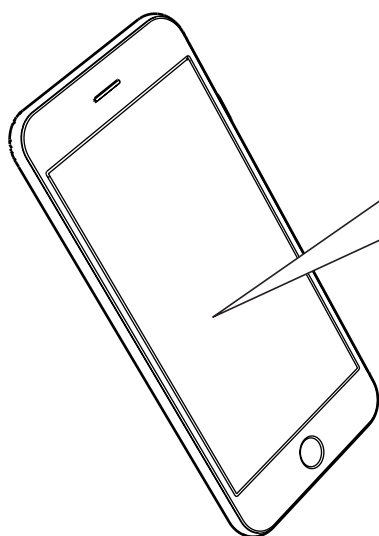

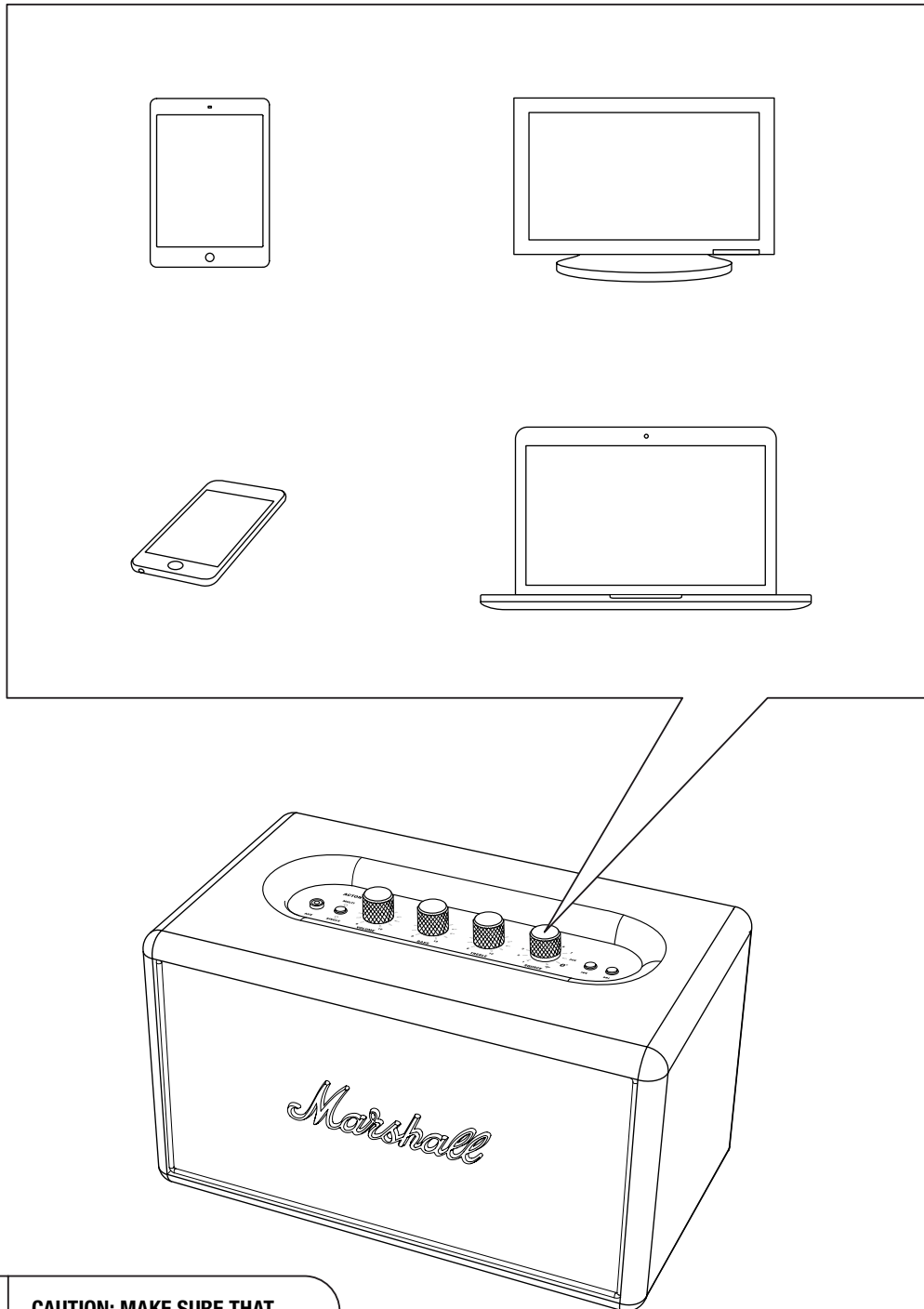

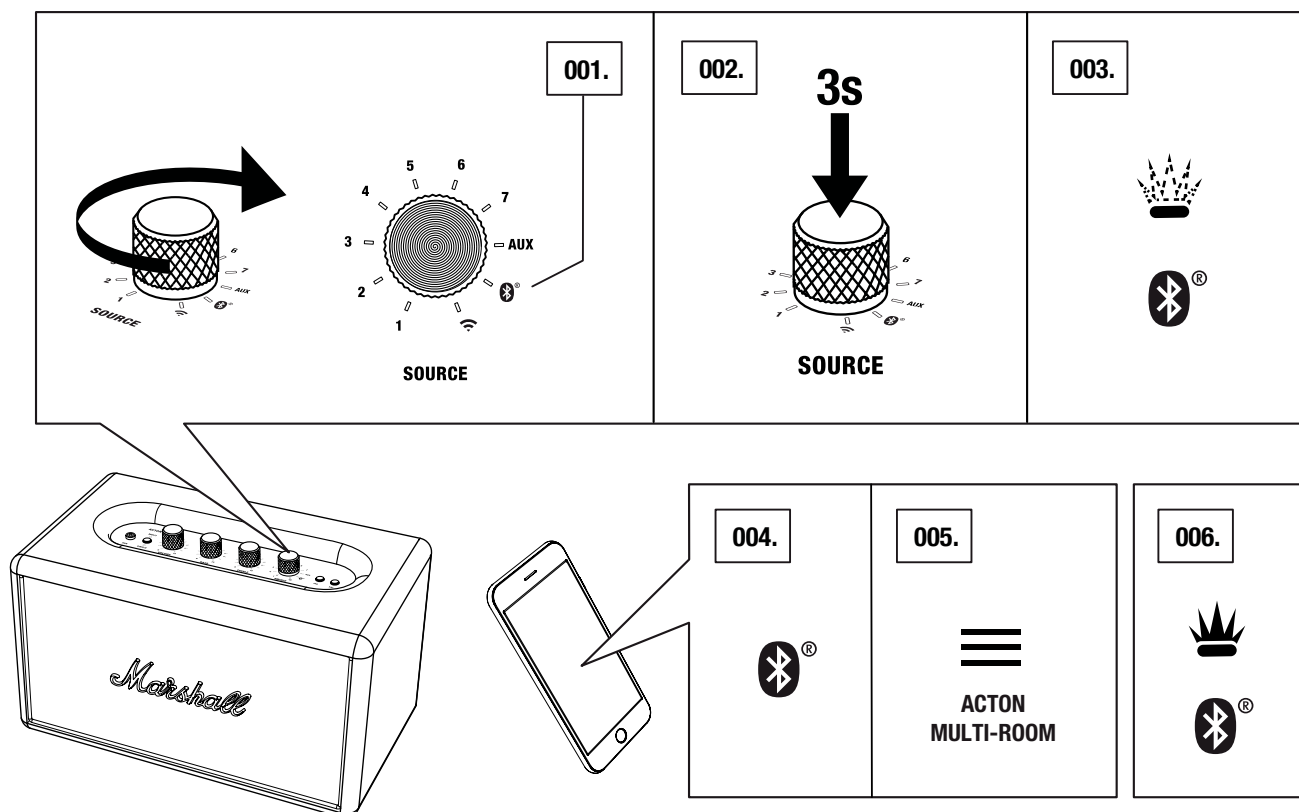

THE ACTON MULTI-ROOM STORES UP TO EIGHT Bluetooth DEVICES AND TRIES TO CONNECT TO THE LAST CONNECTED DEVICE FIRST. FOR EXAMPLE, IF THE SPEAKER HAS BEEN CONNECTED TO THE DEVICES: **A B C D E F G H**, DEVICE **H** IS GIVEN FIRST PRIORITY, WHILE DEVICE **A** IS GIVEN LAST PRIORITY. 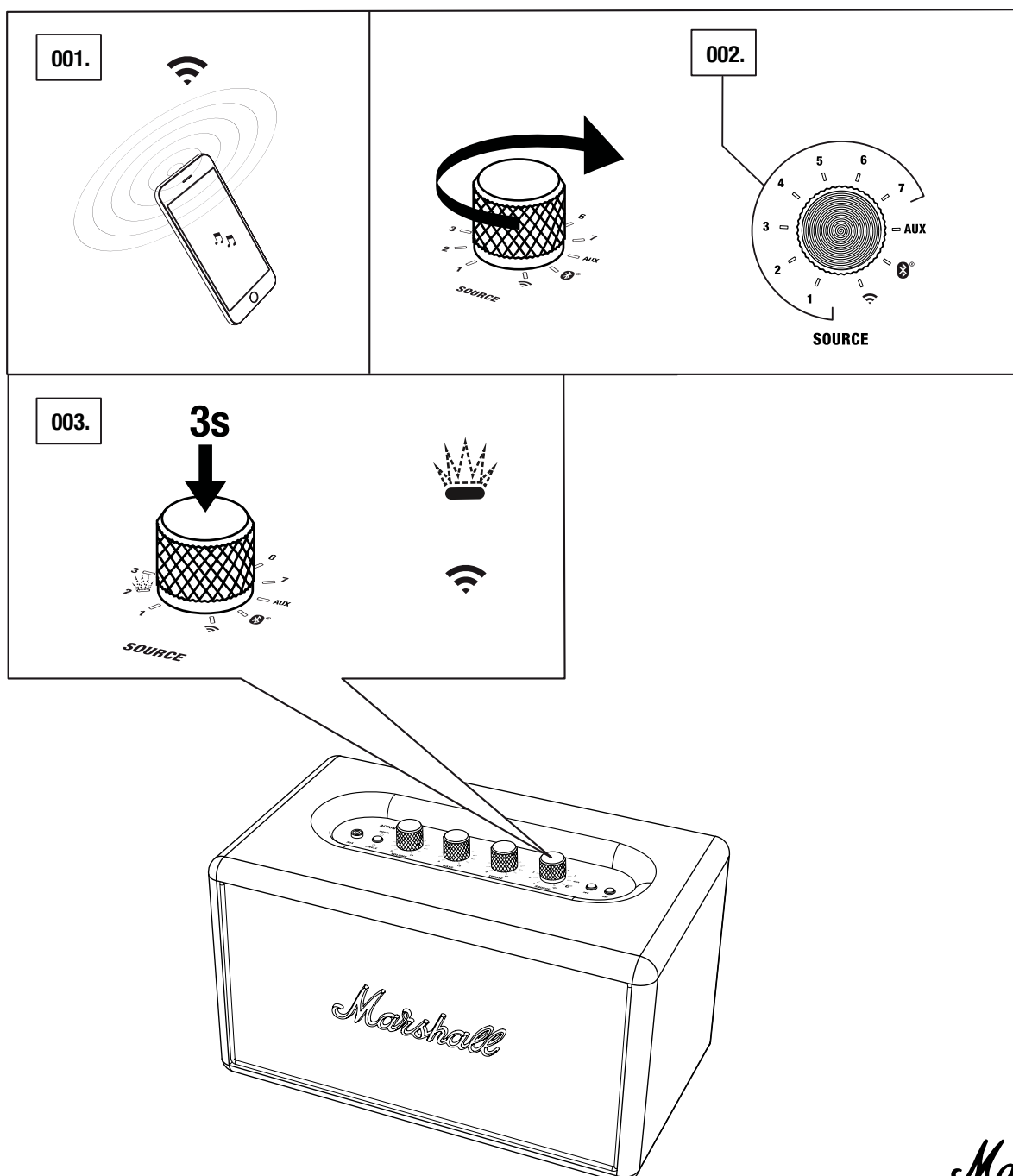


STORING PRESETS

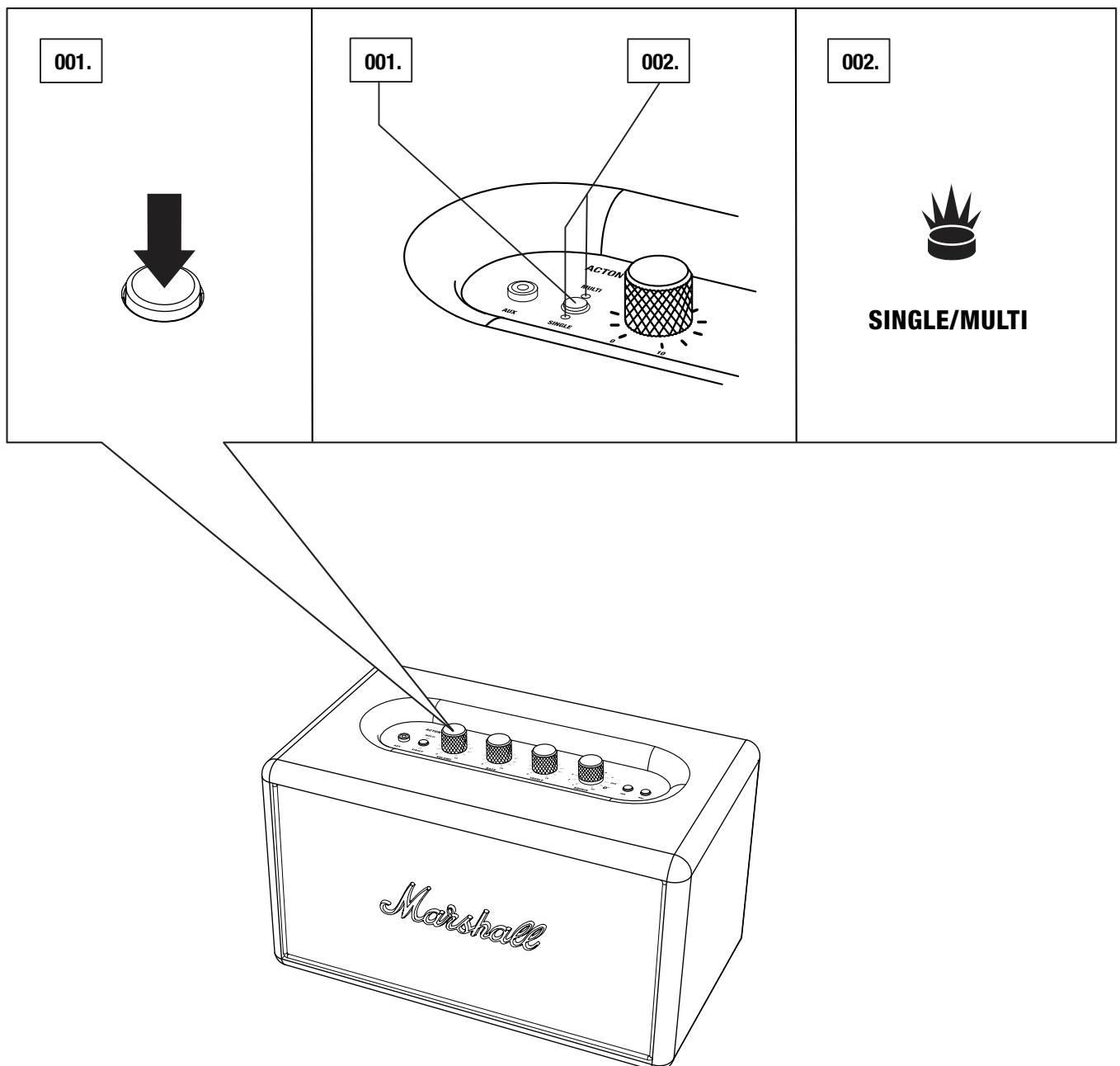

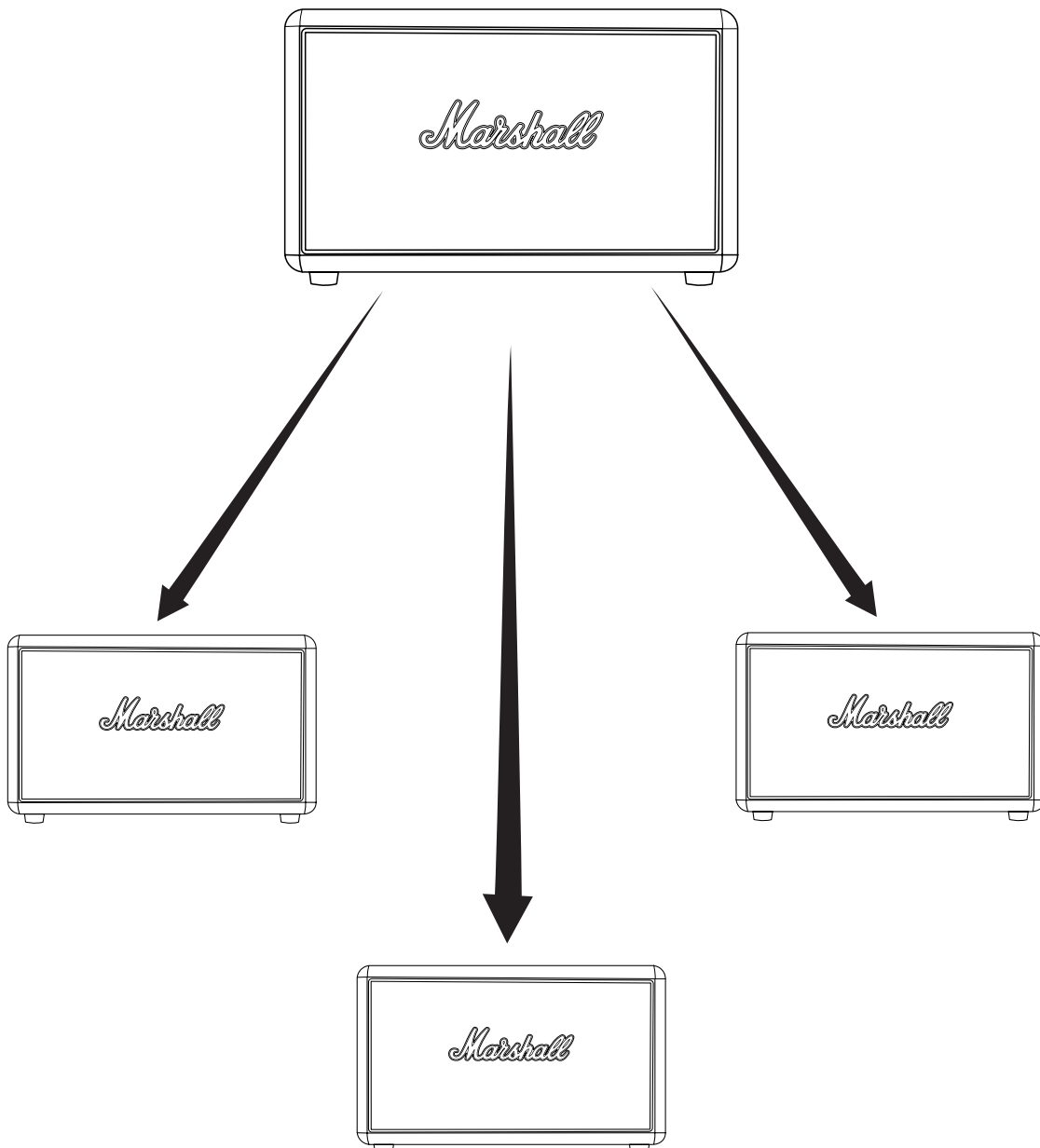
